ORDER

The President, Seen Educational Trust, Vatakara, Kozhikode vide paper read as first above, has applied for starting new college with self financing programmes B.Com, BBA, B.A English, B.Sc Food Technology& B.Sc Chemistry for the academic year 2016-17 & 2017-18 after remitting the fee required.

2. The Chairman, Seen Educational Trust, Vatakara, Kozhikode vide paper read as second above, has

requested to change the programmes from B.A English to B.A Functional English and B.Sc Chemistry to B.Sc Psychology.

3. The District Level Inspection Commission(DLIC) after conducting inspection, have submitted report vide paper read as third above recommending starting of new college with self financing programmes B.Com Finance(40), BBA(30), B.Sc Food Technology(24)& B.Sc Psychology(24) for the academic year 2016-17& 2017-18 .

4. Recommendation to start the aforementioned college was forwarded to the Government of Kerala for concurrence vide paper read as fourth above.

5. Government of Kerala, vide order read as fifth above, have restricted sanctioning of new self financing colleges and new programmes.

6. The resolution of the Syndicate to comply with the Government Order detailed in paragraph(5) was implemented vide University Order read as sixth above. Some educational agencies including Seen Education Trust have approached the Honourable High Court of Kerala against this and the University was directed vide paper read seventh above to reconsider the applications submitted by the petitioners and to pass appropriate orders within a period of one month.

7. The matter was placed before the Syndicate and the decision of the Syndicate to grant affiliation only on the basis of the recommendation of the District Level Inspection Commission(DLIC) and NOC from the Government, was implemented vide University Order read as eighth above.

8. Consequently, the educational agencies filed contempt of court against the University and the Syndicate reviewed the decision detailed in paragraph(8). The resolution, to consider applications for starting new colleges and programmes in accordance with the provisions contained in the University Statute and to constitute an academic expert committee to inspect the colleges was implemented vide University Order read as ninth above. Academic expert committee was also appointed vide this order, to verify the physical, instructional and infrastructural facilities available in the proposed new colleges including Kadathanad Arts& Science College under Seen Education Trust, Vatakara.

9. Academic expert committee submitted report vide paper read tenth above, recommending to start Kadathanad Arts & Science College under Seen Education Trust, Vatakara , Kozhikode with self financing programmes B.Sc Food Technology, B.Sc Psychology, B.Com Finance, BBA & B.Com Computer Application for the academic year 2017-18 along with certain remarks.

10. Accordingly, the report was placed before the Syndicate and the Syndicate decision to approve the academic expert committee reports in respect of B.Com Finance & BBA only (as it was resolved to grant Arts & Commerce programmes to colleges) and to grant affiliation to Kadathanad Arts & Science College under Seen Education Trust, Vatakara, Kozhikode with self financing programmes B.Com Finance(40) & BBA(30) for the academic year 2017-18, subject to certain conditions, was implemented vide University Order read as eleventh above. Before granting affiliation legal opinion has to be sought in the light of the judgement of the Honourable High Court of Kerala in writ petition filed by Sree Narayana College, Vatakara.

11. Accordingly legal opinion was obtained from the Standing Counsel vide paper read as twelfth above and a committee was constituted to ascertain the academic need of the locality. The committee submitted its report and the Syndicate considered it along with another report on allegations raised by Sree Narayana College, Vatakara submitted by the Convenor, District Level Inspection Commission, Kozhikode.

12. Vide paper read as thirteenth above, the Syndicate have decided to delete the clause regarding granting of affiliation only to Arts & Commerce programmes. The same was implemented vide University Order read as sixteenth above.

13. The Syndicate vide paper read as fourteenth above, have resolved to grant affiliation to Kadathanad Arts & Science College under Seen Education Trust, Vatakara, Kozhikode with B.Com Finance(40), BBA(30) & B.Sc Psychology(24) self financing programmes subject to the fulfillment of the remarks furnished by the inspection commission. This was implemented vide University Order read as fifteenth above.

14. The Principal, Kadathanad Arts & Science College Vatakara, Kozhikode vide paper read as seventeenth above, has requested to grant provisional affiliation to the college with B.Com Finance(40), BBA(30) & B.Sc Psychology(24) self financing programmes for the academic year 2017-18. Affiliation fee and administration fee ₹55,000/- (Rupees Fifty five thousand only) was remitted at University chalan counter vide chalan numbers 1892369, 1892370 & 1892371 dated 18.07.2017.

15. Notarized undertaking in stamp paper worth ₹200/- (Rupees Two hundred only) duly signed by the Principal of the college and the Manager of the educational agency agreeing to carry out faithfully the provisions of the University Act, Statutes, Ordinance, Regulations and directions issued by the University from time to time was also submitted vide paper read as eighteenth above.

16. The Principal has also submitted undertakings vide paper read nineteenth above, agreeing to comply with the remarks of the subject experts in respect of the aforesaid programmes within three months period.

17. After perusing the case in detail, the Honourable Vice Chancellor as per paper read twentieth, has accorded sanction to grant provisional affiliation to start new unaided college namely Kadathanad Arts & Science College, Mandarathur P.O, Vatakara, Kozhikode (District) with self financing programmes B.Com Finance (40), BBA (30) & B.Sc Psychology (24) for the academic year 2017-18, under Seen Educational Trust, Vatakara, Kozhikode.

18. Provisional affiliation is therefore granted to start Kadathanad Arts & Science College (Unaided) Mandarathur P.O, Vatakara, Kozhikode under Seen Educational Trust, Vatakara, Kozhikode with following self financing programmes for the academic year 2017-18, purely based on the University Order read fifteenth above, subject to the terms and conditions mentioned hereunder.

19. **The Principal shall strictly follow the syllabi approved, available in the University website www.universityofcalicut.info for selecting complementary courses.**

20. Selection and admission shall be made only on the basis of the rules and regulations of University/Government and on the basis of the directions issued by the University/Government from time to time failing which affiliation granted will automatically be cancelled.

21. In the light of the directions of the Supreme Court of India in WP(C) 656/1998, the institution shall take stringent measures for prevention of ragging in any form. In case of failure to prevent such instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.

22. **Since Centralised Admission Process(CAP) for undergraduate programmes has already been**

completed, the Principal shall admit students in conventional mode with necessary provisions for obtaining CAP ID. The Principal has to strictly comply with the Schedule of Admissions provided along with this order and to report accordingly.

23. Affiliation granted is strictly provisional and only for the academic year 2017-18. The college has to apply for continuation of provisional affiliation to the programmes for the ensuing years remitting the fee fixed by the University from time to time.

24. The list of colleges which have renewed provisional affiliation or applied for continuation of provisional affiliation will be forwarded to the Office of the Controller of Examinations to ensure that examinations are not conducted in those colleges which have not applied for the same.

25. The conduct of University Examinations of any sort including that of SDE examinations is compulsory and binding on all colleges affiliated to the University of Calicut.

26. Admission to the next academic year shall be made only after obtaining prior permission from the University.

27. The Principal has to comply with the remarks of the subject experts in respect of the programmes concerned within three months period and to forward a compliance report along with strict documentary proof.

Orders are issued accordingly.


